BUSINESS MANAGER'S REPORT

We have had plenty of work around the state this work season, but we've also had plenty of rain. It seems like we had rain at least every two or three days there for a while, and because of it, it took a lot longer for some projects to get going this year. Let's all hope we can stay dried out for the most part and have a good finish to the season.

We still haven't seen any changes to the unemployment cuts that happened in Iowa a couple of years ago. There was a group of Union and non-Union contractors that were working together to maybe put some pressure on Governor Kim Reynolds to exempt the construction industry from the changes, but then Reynolds announced she was looking at cutting the amount of unemployment that the contractors would have to pay in. Not surprisingly, the contractors that didn't like the unemployment changes went silent – assumingly because it was going to save them money.

Our Health and Welfare Fund remains in good condition but with the costs of healthcare constantly increasing, we are keeping a close eye on it. Our actuary is still saying that our plan is the best that he deals with, in terms of financial health, benefits and cost. With that said, one of our most important goals is to make sure and stay ahead of any financial issues, and continue to put adequate money towards contributions into the Fund, if needed, and even a little bit when not needed. We still need to take advantage of the Dr- On-Demand program and generic drugs whenever possible to help keep costs under control. Remember, even though your insurance cards say Blue Cross Blue Shield, we are still a 100% self-funded plan. That means every dollar spent comes directly out of our Fund.

We had a great turnout for the Family Picnic this spring at the Training Site. We had the equipment ready for anyone to run it, and we had inflatables for the kids. The last two years we have had food trucks instead of the typical type of food for a large number of people. It seems everyone really likes the options available. We will have it again next spring – if you haven't been to a Family Picnic before, please join us, everyone seems to have a great time!

The Training Program continues to add new equipment and new classes for the Memberships' benefit. Having the necessary certifications and staying familiar and proficient on all types of equipment is a benefit to each Member, as well as our signatory contractors. Keep an eye out for the training schedule that usually comes out around Thanksgiving and get signed up for any classes you may need. Some of the remote training classes that the Instructors have been doing are offered multiple times throughout the training season. I'm not saying that they won't continue to travel, but sometimes the timing of the travel presents problems. Our International training site in Crosby, Texas continues to offer classes that we do not. So, if you are interested in something that you don't see on our schedule, please check the International training site. The International will pay for transportation, lodging, and meals for any Member to attend the classes they offer. Local 234 pays into the International Training Fund, so our Members might as well take advantage of it.

I hope to see everyone at the General Membership meeting in Des Moines on Saturday, September 28th at 11:00 a.m. Lastly, remember to stay updated on the outof-work list if you are not working.

The 2024 construction season got off to a slow start with Mother Nature not cooperating, but as I am writing this, we have several contractors reaching out to the agents with additional manpower needs. If this is any indication, it looks like a strong finish to the year.

Seven of Local 234's signatory public groups around the state have contracts that are open this year. Members

of these groups will be voting in October to recertify to keep Local 234 as their bargaining agent. As soon as the groups recertify, the agents will be taking proposals and



working on scheduling meetings to sit down with the employers to start bargaining. We also have four public groups whose contracts will be open for wages only.

To all the members that work under our Heavy Highway or our "Old AGC" contracts: we will be breaking down the previously negotiated increases that become effective December 1st during the October District meetings. If you want to have a say in where YOUR money is allocated, please attend the meeting in your District.

Local 234 Representatives are consistently attending public meetings, talking to non-Union contractors and non-Union workers to discuss the benefits of employing or becoming Union Labor. If anyone has any leads on companies or future members, please contact your Business Representative or Local 234's new Organizer, Chad Small. I urge all Members to get behind Chad as he begins his work to increase the Local's market share.

Our industry is constantly evolving. It is our responsibility as Members to keep advancing our skills and certifications to keep up with the needs of our workplace. The utilization of our Apprenticeship/Training Site is a great way to do so.

HEY.....YOU: YEA....YOU:

Are you jeopardizing your right to make a self-pay for your Health & Welfare insurance? Are you jeopardizing your unemployment benefits?

You could be if you don't know the out-of-work list rules.

Do you know the rules? Even if you think you do, please read them again!

- 1) You must have your name on the out-of-work list if you are laid off.....EVEN IF you believe you will be returning to work for your previous employer.
- 2) You must check in at least once every 30-days to remain on the list. Your name will be dropped on the 31st day.
- 3) In order to put your name on the out-of-work list you can:
 - Call the Des Moines office 515-265-1657
 - Email the Des Moines office office@Local234.com
 - Check-in at the Des Moines office in person
 - Call your Business Rep
 - Log-on to the website (Local234.com) and check-in through the 'Members Only' section
 - Mark 'yes' for the out-of-work list on the sign-in sheet at a Union meeting
- 4) You must be on the out-of-work list in order to make a self-pay for Health & Welfare.
- 5) You must be on the out-of-work list and be a Member in good standing for unemployment benefits. If the unemployment office does an audit on you, and you are not on the list or not in good standing, the office will not lie. This may lead to you having to pay back your unemployment benefits.

Is your address, email address and phone number current with your Union?

If not, drop us a note or call us at 515-265-1657

The annual assessments of defense fund (\$2 per year) and good standing fund (\$1 per year) are due each year on July 1st, which pays your assessments through June 30th of the following year.

What a wet season we have had! Pipeline work has been steady with maintenance and integrity work. The Local attended the public information meetings that the Iowa Utilities Commission scheduled from August 26th through September 20th. These meetings were held in the 23 counties where the additional ethanol plants were located that Summit Carbon Solutions picked up after Navigator abandoned their proposed project. Back in June, the Utilities Commis-

sion approved Summit Carbon Solutions' Iowa permit, with the requirement that the company also obtain permits in South Dakota, Minnesota, and North Dakota before construction can begin in Iowa. Distribution pipeline has been busy with new relocate work, but slow on the blank plastic work.

Building work was a little

slow to start this season, but it looks like it's starting to pick up. We still have a few Operators working at the Des Moines International Airport. Northwest Steel Erection will be starting an addition at Kemin Industries in Des Moines.

Dirt work has also been steady – when it's not raining. Local 234 signatory contractors have been busy doing housing developments, interstate work, data center additions, and commercial projects. Union contractors have also picked up street projects around Des Moines. However, the big sewer work has been really slow this season.

On the Stationary side, several groups will be going through the recertification process in October.

The workload in District 2 has been busy this construction season with some large projects ongoing. Mortenson is moving dirt on a big data center project in Cedar Rapids. They are also working on the Vienna Windfarm repower project near Tama. Work at the Palo Solar Farm in Linn County is starting to slow down, and at this time, there are no other phases currently scheduled to start. Mountain Crane has been

working on a wind farm repower project near Iowa Falls. That project should finish later this year.

Work at the Lansing bridge project has been a challenge this year. There was flooding, and between the drilling and the unstable ground under the water, the old bridge moved. It seems that things are back on track now, and the project is moving forward. Work will be starting later this fall at the Cedar Rapids Wastewater plant and will be a multi-year project. There will be public informational meetings which were approved by the Iowa Utilities Commission in



Iowa, including the District 2 area, regarding the Summit Carbon Solutions pipeline project. Local 234 staff will be attending each of these meetings.

As a reminder: with most jobsites requiring OSHA 10 and First Aid/CPR training, I urge you to take advantage of any down time you have during the winter season. Please use the Training Site to get these certifications and any others that you think you may need to keep yourself the most employable. Also, when/if you get laid off, please contact the agent who put you to work to be added back to the out-of-work list. This will also help them to know the status of Members, and keep track of the progress on the project.

The Local will also be having recertification elections with public stationary groups in the fall of 2024. After recertification, proposals will be taken and then negotiations will begin.



The Council Bluffs area remains busy with the Google/ SLN project. Contractors performing work on that project include JE Dunn, Global Underground & Earthworks, Barnhart, Patriot Crane, Topping Out/Davis Erection, MMC, and now McAninch. The focus of work is on Buildings 5 and 6. In the Carter Lake area, Meyer Contracting is installing underground utility pipe and working on the

concrete removal on H Ave.

The Creston/IPL solar farm outside of Creston, Iowa is nearing completion. AZCO Operators are loading out, cleaning up the job site, and mowing. Rachel Contracting will return to fill in a few temporary ponds, along with site clean-up and reclaiming the rest of the lay down yards. The Creston School solar site is also almost complete, with the exception of transformer parts, which will be set as soon as they come in. Herberg-



er Construction is also in the area replacing three Union County bridges.

We are coming up on the stationary agreement negotiations for the year. Within the units that I cover, we have the City of Corning, which will be engaging in full contract negotiations. I will also be negotiating with Iowa Western Community College, the City of Atlantic, and the City of Chariton on wages only.

This is the most effective way to inform the Business Representatives of your skills and certifications. Also, when/if you get laid off, please call the agent that put you to work to place your name on the out-of-work list.

The Member Management System, or database, that the Local staff started using last October is proving to have been a good decision. Of course we've had some bumps along the way, but all in all, things are going well. The abilities to pull needed information out of the system has helped in several ways for the staff.

We will be ready to welcome

all Members into the system on October 1. You will be able to access the system by going to <u>https://iuoe234.</u> <u>unionfusion.net/Auth/Register</u>. You will be asked to verify that you are who you say you are by putting in personal information.....this will include your Register

number, SSN and date of birth (your Register number is on your Union card). If your answers match what is in the system, you will be taken to a new screen. There you will have to add/verify your phone number and email address. You will be able to set your own password! It seemed that Members had troubles remembering passwords getting into the old system, so we made sure this time round you could create your own password. You can log in using your phone, tablet or computer. One key benefit is that Members will be able to pay their dues in Union Fusion.

Everyone that works on the construction side of the Local should have received the Annual Funding Notice from the Central Pension Fund in May. This Notice shows the Central Pension Fund is 107.7% funded. This means, the Fund has 100% of the assets to pay all of its liabilities and make all anticipated payments, plus another 7.7% on top of that.
